1. <u>PLEDGE OF ALLEGIANCE</u>

Township High School District 214 Board President Kreutzer led the Board members and audience in the Pledge of Allegiance.

2. <u>PUBLIC COMMENTS</u>

Township High School District 214 Board President Kreutzer asked if there was any member of the public who wished to address the Joint Boards of Education. There were no public comments.

3. STATE AND FEDERAL LEGISLATIVE UPDATE

E. Aumiller, superintendent of Mount Prospect School District 57, introduced the other school superintendents in attendance: K. Hyland, Community Consolidated School District 21; L. Bein, Arlington Heights School District 25; D. Delli, River Trails School District 26; A. Fessler, Community Consolidated School District 59; J. Hackett, NSSEO; and D. Schuler, Township High School District 214;

- D. Schuler, superintendent, Township High School District 214, provided a brief State and federal budget and legislative update.
- J. Hackett, superintendent, NSSEO, described the ongoing efforts to lobby for changes in the Individuals with Disabilities Education Act (IDEA).

K. Hyland, superintendent, Community Consolidated School District 21, explained how the area superintendents are collaborating on the legislative issues, current and new mandates, and professional development.

B. Harrison, board president, Community Consolidated School District 21, addressed the group as a member of the executive board of Ed-Red. He requested that board members notify the executive director, C. Valadez, or him with any issues. He suggested creating a legislative committee composed of a Board member from each district. That group could identify several critical issues to discuss with area legislators who would be invited to a meeting with all of the Boards.

4. <u>PreK-14 INITIATIVE</u>

Provost J. Warwick, Harper College, provided an overview of the Harper Promise, an initiative based on a cradle to careers approach for students and developed with the collaboration of the three feeder high school districts and the area business leaders to make college more affordable. Students can earn two full years of tuition-free college by meeting the eligibility requirements and maintaining all of the success factors through their semesters at Harper. Criteria have been identified regarding attendance, taking a rigorous academic program, persistence in maintaining good grades, graduating on time, and community service, all the factors students need to be ready to succeed in their future. Applications are completed in the fall of the 9th grade year, so it is critical students and parents learn about the program while still in middle school.

L. Brown, executive director of the Harper College Educational Foundation, reported that the Harper Promise has already raised \$7 million of the initial \$10 million needed to begin the support of the Harper Promise, part of which was funded by the Harper College Educational Foundation. Donors have stepped up and the Board is energized about raising additional funds. She noted that the Educational Foundation has looked to address the needs of students of poverty through the Harper Ambassador Program for elementary and middle school students. Through activities, such as career days and a special on-campus program for 8th graders, the Ambassadors program seeks to find ways to inspire young students of poverty that "college is possible" and to give back to the community.

5. SCHOOL CALENDAR DISCUSSION

D. Schuler, superintendent, Township High School District 214, noted that districts in the surrounding area have made changes to their calendars, with several starting the year earlier. Increasing amounts of research have been published indicating that the start times of schools may not be the most advantageous for student achievement. He indicated that rather than address each of these as single issues, the community-at-large needs to engage in conversation about all aspects of the calendar and start times as it affects all the districts and families. He described the process that District 214 will be using to engage the community, parents, staff and students in providing input and feedback to determine if there is a better model to meet the needs of children.

D. Delli asked each district's board to spend some time identifying the hopes and the fears that they have regarding having the conversation about the school calendar and start-times. Board members within each district shared their opinions and questions to be addressed and notes from those

conversations will be aggregated to identify consistent themes to address as part of the ongoing dialogue with the community.

A. Fessler and L. Bein addressed the need of the boards to be courageous and thanked them for their collaborative efforts to prepare students to be successful for their future.

6. <u>ADJOURNMENT</u>

The meeting adjourned at 8:29 p.m.
