8.01 PTAB Authorization to Intervene On Assessment Appeals

MOTION by Mrs. Roberts, seconded by Dr. Burns to approve the following resolution:

<u>WHEREAS</u>, an owner or manager of a parcel or parcels of real property located within the boundaries of the State of Illinois has the right to file an appeal challenging the assessed value of a parcel or parcels of real property with the State of Illinois Property Tax Appeal Board ("PTAB"); and

<u>WHEREAS</u>, an appeal before the PTAB seeks a reduction in the assessed value of the parcel or parcels; and

<u>WHEREAS</u>, a reduction in the assessed value of a parcel or parcels granted by the PTAB on property located within the boundaries of the Board of Education of Community Consolidated School District No. 59 will lead to the issuance of a real estate tax refund from the Board; and

<u>WHEREAS</u>, a taxing district has the right to intervene in proceedings before the PTAB in order to protect the taxing district's revenue interest in the assessed value of a parcel or parcels; and

<u>WHEREAS</u>, the time period during which a taxing district may intervene is within 60 days after the taxing district's receipt, from the local Board of Review, of notice of the filing of an appeal by an owner or manager of a parcel or parcels of real property; and

<u>WHEREAS</u>, the Board has determined that it is necessary, desirable, advantageous, and in the public interest to defend the Board's real property tax base by intervening in PTAB appeals filed on parcels within the boundaries of the Board.

NOW THEREFORE, BE IT RESOLVED, by the Board of Education of Community Consolidated School District No. 59, Cook County, Illinois, as follows:

Mary Cosenza Vicars April 2, 2018

Why does she care? She doesn't have any kids in the school. Her voice shouldn't count. She doesn't have any skin in the game. She is mainly concerned about her property values.

These are some of the comments that I have heard since I have been involved in District 59 issues:

I have lived in my home for almost 31 years. I was President of the Homeowners Association for two terms. I have helped run local mayoral and trustee campaigns. I helped remove a nightclub from our neighborhood because it violated village ordinance. I got some of my neighbors to treat their ash trees when the village would not treat them for the ash borer disease. I was on a commission that draft a village ordinance which the board approved. I was very active in the PTO and on school committees at Juliette Low and Holmes. Currently I volunteer with poor families. I am not here to brag but to ask you, do I sound like a person who has no skin in the game? Does that also mean that only two of the seven board members have skin in the game because only two have children in 59? Whether I have convinced you that I do have skin in the game, the government thinks I do because it allows me to vote for my District 59 Board members.

Do I care about my property values? I don't think anyone in the room can honestly say that they don't care. I bought my home almost 31 years ago. If I sold today, I would make money on my home. Can some of you who bought shortly before 2008 say the same thing? So, who is more concerned with property values—the younger families or us older folks?

Others say that when I voice my concerns at a board meeting or on social media, including Board member Janice Krinsky, I am negatively bashing the school. Keeping quiet is what we have done, and where has that gotten us? For a long time, folks have moved from District 59 to get into a better school district and others will continue to do so, until the scores improve. What is different about today than years ago is that young families look on the Internet to check out the schools, before they look at a house. We have low scores and a downward trend, cause for concern. When Joan Burke read what Zillow said, "You are better off buying a home in 57 rather than 59," do you think that she was the only one that read that? When you look at Juliette Low and how few students have met or exceeded standards on this test, does that make you want to buy a home in my neighborhood if you would like to send your children to public school? When Art said that there are only 100 neighborhood children attending Low, while neighboring districts are bursting at the seams with students, doesn't that tell you something? When children of folks in the neighborhood buy homes in other parts of AH, when our homes are more reasonable, doesn't that also tell you something?

So, we can only say positive things about our district, but until we start working together to address the serious academic issues that our schools face, we are hiding our heads in the sand. You can have your art fairs, talent shows, Pepsi Challenge, but I want higher PARCC scores. How would improving PARCC scores hurt our kids and hurt our communities, as some have accused me? It's time that we work together to look at how we can improve the academics in our schools for all kids—not just the those in TDP or the English-speaking kids in the Dual Language Program. It's time we think about all our kids in the District—not just your own. I would say that all of us have some skin in the game.

Judith Cox Presentation to the District 59 Board- April 2, 2018

I'm still looking for a District 59 curriculum. In deciding what to speak on today, my mind was all over the place. So I decided to revisit an area that I find puzzling and troubling..the District 59 curriculum.

A good curriculum, as defined by multiple research based sites, is "built on evidence based pedagogy, research, introspection and shared experiences". The curriculum is WHAT is taught- the assignments that are given, the books that are read, the projects that are assigned, the videos used, the readings referred to, the units being emphasized, the separate lessons taught daily, and the vocabulary What I found in District 59 were 'learning experiences' that were either so specific as to be meaningless or so broad that it was difficult to know what were the expectations on the part of the learner.

A well-designed curriculum means upper grades build on prior knowledge learned in the lower grades. Expectations, knowledge and skills at each grade level should be the same across the district so that a student moving from one school to another will be learning the same material. (although the material may be presented in a different way depending on the teacher). A good curriculum should reliably address the same learning goals and hold the same opportunity for student achievement across the board.

Before I came to speak today I had to use what I had been taught, or learned, to plan, write and organize my thoughts. I read materials, both in paper form and on-line, jotted down ideas from what I remember as a learner, and put together this presentation. This is called using Prior knowledge.

It is the job of the primary school to conscientiously and purposefully build prior knowledge, vocabulary, and background content, so the students can understand new ideas and build a foundation on which to tackle more complex projects and problems. Children need to have a rich oral, reading and writing vocabulary They need to be taught important words (words that help a child better understand the world...animals, occupations, geography etc.) Students need to be exposed to new words multiple times before they can "own" them. They need to "live" these new words. They need to enjoy words and love learning. Children in all grades need to be exposed to a range of increasingly complex literature and informational texts and tasks. Simply having the content available in libraries and on line is not enough. Children need adults to guide them to the content and adults to help them understand it. And I have yet to find any reference to the role of parents in their children's education.

What are the students of District 59 reading? I can find no reference to any written material or books that I can access. I have not found any reference to terms, vocabulary, facts, shared readings, word studies, or specifics as to the informational texts and books used. All of the "experts" referred to by the District sent me to websites with materials for sale. What the District owns or uses from these "experts" is still unknown to me.

In education change is expected...Districts adopt or develop programs as needed and review of curriculum and change is a constant. But in the case of 59 they eliminated most of the old curriculum and started from scratch. From what the District has told the public, there was no time for the "experts" to adjust to the new standards. I find this hard to believe since all of the other districts in the area have managed to find and adopt a new curriculum. It seems that our District's curriculum was developed as needed. They are still in the midst of the initial development and are at the stage where the curriculum is subject to a vigorous review process. In the meantime.....

If the district is only interested in evidence that fits their ideology and if they are ignoring other ideas and evidence that doesn't fit into their agenda, they are doing the children, the parents, and the community a disservice. We all deserve more, especially our children. Their education is their future.

Recently, I have had a chance to review a number of financial documents that are found in School District 59 reports that are located on the internet. These more than one hundred page long reports are long on data but short on narratives. They are backward looking, but they offer insights into the direction the District is heading. I don't have a formal background in finance so as a lay person, the volume of data is somewhat intimidating. As a result, I have a number of questions which I will be submitting in the future. However, some things just jumped out at me during my reviews.

Debt service costs as a percentage of budget continue to trend downward, which is fine, but the cash available, or money in the checkbook, as represented by the July 1 Beginning Balances data has taken a precipitous drop in the last two years.

The administration staff's Organizational Chart has morphed from 2009's seven "boxes" for administrative personnel positions to fifteen boxes in the 2017 budget, with three of those boxes listing "Coordinators"- plural. Times change and we have to change with them, but when more than doubling administrative staff positions is coupled with declining test scores, it seems to indicate that something is wrong – somewhere. We have to figure out where. Others will talk about curricula and methods, but it is also important to see how the money available is being utilized for the benefit of the students.


For instance, in the District's Long Range Fiscal Plan there is a statement: "As a result of the presentations from Forecast 5 (a vendor) and with the Board of Education's approval, the 5Cast and 5Sight software modules will provide the Board of Education with tools needed


for financial modeling, reporting, benchmarking and forecasting." Great. So, is the \$132,000 paid to the Skyward company in 2017, for services described in their web site as "Financial management and human resources software", a duplication of software or did Forecast 5 just fail to work out as promised. As I said, narratives are missing.

The most current Vendors over \$25,00 list which is for 2016-17, has some things that need more explanation than just a line item mention. Based on vendor company web sites, two companies that provide school and office furniture either supplied, or billed, more than \$999,000 dollars for their products last year. Firms whose web sites described themselves as professional development and teacher training services were awarded nearly a quarter of a million dollars (\$221,000), and an individual whose web site describes him more as a Tony Robbins type motivational speaker than an educator, was paid \$115,000. Website design for \$75,000 dollars?

At a time when the District is searching for an additional five million dollars in budget cuts, which must not detract from students' learning, it is time to look at the cost of such bigticket items in addition to the "cutting around the edges" list that has already been developed. The District appears to have the money. Now is the time to make sure that that money is totally focused squarely on the <u>children</u> of the District.

My name is Jaime Esler, and I have a 3rd grader at Juliette Low. Having a child in a D59 school means that I have a front row seat to his education and what goes on the classrooms. It is so hard to sit at these meetings, or see things posted on social media, that are blatantly incorrect. I can understand how the mistakes happen – the people making those statements don't have that same front row seat as I do. But the problem is that other people take these misstatements as 100% truth, and that snowballs into more outrage, more anger and more inaccurate statements. It is a vicious cycle. The only way to break the cycle is to educate yourself more on what happens in the schools, and to not generalize about all students and all schools.

As we have all seen, words are a very powerful tool. And because of their power, they should be used responsibly.

I can only shudder to think about what would happen if a parent looking to enroll his or her children into a D59 school came to one of these meetings. A prospective parent should walk in expecting to get a glimpse into the great things being done in the district, and get an understanding of how issues were being dealt with. Instead, that prospective parent would see a divided community, but more importantly, a divided board. So much time is being spent blaming and not listening to one another, and the people that are suffering as a result are the very children we should be fighting for. We can, and should, do better.

There are always ways to improve. Every company I've ever worked for had goals that needed to be achieved. And at every job I've ever had I was measured on my progress throughout the year. D59 should also be held to goals. I have no problem with that. I do, however, have a problem with the sole measuring stick of our student's academic success being an inaccurate standardized test. Teaching to a test will not make our children better 21st century learners. Teaching to a test will not make these children better employees. In my opinion, teaching to a test will not raise our property values.

I'm a tax attorney, and as part of my job, I am responsible for hiring people. I can promise you that I would never hire a candidate that could recite the tax code to me. That's a useless skill. I have a copy of the Code at my desk. I can look anything up that I need. I would, however, hire an individual who can problem solve – who can analyze the sections of the Code and formulate an answer to an issue. Who can think outside the box and apply different concepts and rules to the problem at hand. Who can explain the issues to me. That is a valuable skill to have. Teaching those skills and concepts will make our children better 21st century learners and set up them up to be successful in life.

I spoke last meeting that despite low PARCC scores, our children are thriving in the classrooms. I would like to provide another example. The first-grade class at Juliette Low studies poetry. The kids are taught about and write different types of poems, such as haikus, narrative poetry, limerick poetry, and free poetry. At the end of the unit, they invite the parents to a "Poet's Day Lunch," and they stand up and read their poems to the audience. There's your glass half full – an example of great things being done in classrooms. The assignment was challenging, fun and, at least for my son, allowed his imagination to soar. It made him excited to go to school and learn. And again, that assignment won't be reflected in a PARCC test score.
