RESOLUTION: PUBLIC HEARING ON 2018 TAX LEVY

Background

At its October 9, 2018 meeting, the Board of Education discussed and directed the administration to move forward with preparing the levy and to set the public hearing date for November 19, 2018. The state's Truth in Taxation Law requires that if the estimated levy exceeds 105% of the prior year's extension, the district must give public notice of and hold a public hearing on its intent to adopt an aggregate levy. While District 59's proposed levy does not meet this 5% level, the administration believes that meeting the spirit of the law is in the District's and community's best interest.

Therefore, this Resolution authorizes the Board of Education to hold a public hearing regarding the levy prior to adoption. Following the public hearing, a resolution should be approved adopting the levy.

Recommendation

The administration recommends that the meeting be opened for public comments and/or requests for consideration prior to adoption of the 2018 tax levy. Resolutions to open and to close the hearing follow:

<u>RESOLUTION:</u> Approval of Submission of the Title I School Improvement Grant - 1003(a) Grant Application

Background

The Title I 1003(a) grant is designed to allocate funding to Local Education Agencies (LEAs) as part of the Illinois Every Student Succeeds Act (ESSA). The funding will be allocated and monitored through IL-EMPOWER, which is a statewide system of differentiated supports and accountability to improve student learning, purposely designed for capacity development to leverage schools' strengths to meet student needs. This new structure replaces the single-provider model currently in place and empowers schools with greater choice and collaboration that is informed by data assembled through a needs assessment and equity analysis. IL-EMPOWER promotes collaboration and peer-to-peer learning as vehicles for educator-led and state-supported school improvement.

Background

Provisions of the Illinois Open Meetings Act (<u>Ill Rev. Stat.</u>, Chapter 102, Section 41, et. seq.) stipulate that all or part of a meeting may be closed to the public upon a majority vote of a quorum taken in any properly called open meeting. The minutes shall disclose the vote of each member on the question of entering closed session and shall state the specific statutory exception authorizing the closing of the meeting. A single vote may authorize a series of closed meetings on the same topic within a three-month period. Minutes shall be kept of all closed sessions and shall record the date, time, place of meeting, members present and absent, a summary of discussions of all matters proposed, discussed or decided, and a record of any votes taken. No final action may be taken in closed session.
