Mary Cosenza Vicars BOE Speech April 29, 2019

After two years of coming to school board meetings, and listening to what you have to say, I think I know you all very well. I would like to address my remarks tonight to the board members who will be leaving the District 59 School Board.

#### To Barbara:

After being on the District 59 School Board for 40+ years, it will be different for you to not be going to school board meetings every month. It is probably going to be like me or anyone else after they leave a job that they had for so long. There will be things that you will miss-probably the state meetings, but I am sure you will not miss many of the board meetings. The Administration and board like to talk about collaboration, but this board does not work well together. Several of the members not only disagree but don't like or treat each other well. Numerous times board members have felt that they have had to talk from the podium to be able to voice their opinion. I am thankful that they have. From my seat in the audience, I have seen plenty of eye-rolling when members speak or comments such as, "We have already discussed that." I am sure that you won't miss that. Barbara, you had an opportunity to serve the 59 Community longer than most and you should be grateful for that. It would have been difficult for any incumbent to run in this past election. Unless the board changes dramatically, it will be difficult for any incumbent to win in 2021. There are a lot of folks who do not think highly of this board and Administration. As a board president, you did a good job. You didn't bang the gavel or call the police on the residents when they were not out of hand, and you got along with the residents who came to speak before the board. You are a decent person and I am sure you will be happy in the next chapter of your life. When things settle down a little, I hope you will still be engaged in 59 affairs and attend meetings. As a long-time member of this board, there is a lot of knowledge that you have. After all, you must have cared about kids a lot to seek this position and so we hope that you will show your concern through your involvement. It's not bad sitting on the other side of the room. Barbara, I wish you well.

#### To Tim:

I will miss seeing you on the board. I will miss your stories—not always sure where they were going, but there always was a point to them. You did what good teachers do—you start class with a hook, often a story to get students' attention and then tie that into the lesson or point you are making. It is obvious that you are an educator. Probably the funniest line in the two years that I have known you is when you said after the board discussed whether they should pay for student fees was: "If I don't have to pay fees, I am going to spend it on booze." I like your sarcasm. Not sure some other members did.

Most of all, thank you for advocating for all kids in the district—low-income, ESL kids, Special Education Kids, non-low-income kids, not just your own. You are concerned, as many of us are, that our ESL students are coming out of our district without the skills and English-language skills to be successful. You said once that if we don't teach these kids well, we are relegating them to a career in a low-paying job. (You said it much better than me.) You weren't afraid to ask the hard questions even though you knew you would be outvoted. It couldn't have been easy with the Board and Administration voting as a block, but you never backed down. I appreciated that. As an Arlington Heights trustee told me, "It's not the questions that you ask that count but the ones that you don't that matter." Tim, thank you very much for your service to our community. I hope you will be continued to be involved. Thank you

#### **ATTACHMENT #3**

I was encouraged to learn that the Board did not approve a pay increase or contract extension for Dr. Fessler. In connection with that topic, I will share with the Board various excepts from a paper titled "School Superintendents: Vital or Irrelevant" published by the Brown Center on Education Policy at Brookings Institute in September 2014 I'll provide a link to the paper after I am finished speaking.

- "Our results make clear that, in general, school district superintendents have very little influence on student achievement in the districts in which they serve."
- "The transformative school district superintendent who single-handedly raises student achievement through dent of will, instructional leadership, managerial talent, and political acumen may be a character of fiction rather than life. At the least, such individuals are very difficult to identify using quantitative tools. Further, real superintendents, defined as the entire class from the best to the worst, have very little influence on student achievement collectively compared to all other components of the traditional education system that we measure."
- "Superintendents associated with substantive improvements in district performance are quite rare, likely to be playing a part in an ensemble performance that doesn't depend uniquely on them, and difficult to identify reliably using the best empirical strategies presently available."

After reading the paper and thinking about issues within our district regarding controversial curriculum, finance/budget issues, the Taj Mahal of Admin Building and declining PARCC scores over a period of years, it appears that the paper's conclusion is correct: (i) superintendents have very little influence on student achievement and (ii) it is the parents, teachers, classrooms and curriculum that are the key factors effecting outcome.

Why are we paying a premium for this position given the outcome we have been receiving for years? My message to the Board is a permanent pay freeze and no contract extension for Dr. Fessler beyond what is currently agreed. Thank you.
