Mary Cosenza Vicars BOE April 29, 2019

Congratulations to Patti, Randy, and Courtney. My speech is to you:

- 1. Our scores are low and have been declining on multiple tests for low and non-low-income kids. Nearly all public-school kids take these tests. Some of my neighbors have told me incorrectly that it is the ESL kids that are bringing the scores down. As an ESL teacher, I am appalled by that incorrect statement, because these kids are bright. My response—everyone is bringing the scores down because no one has the advantage of having a good curriculum. What will you do? Our kids deserve better.
- 2. Our curriculum doesn't need a few gaps to be filled, it needs a major overhaul so that basic skills are taught, so that we have scope and sequence, so that our kids are prepared well when they attend high school and ultimately in life as our Superintendent likes to say. What will you do when residents come forward with curriculum concerns like they did two years ago? Wait two year or act now. Our kids deserve better.
- 3. Our Superintendent has created a 75-person curriculum committee and is not committed to making the changes that are needed. What will you do? Our kids deserve better.
- 4. Our district likes to say that our kids are getting out of District 59 being bilingual and biliterate. I think it's great to know a second language, but not at the expense of not knowing how to read and write in English, knowing Social Studies so they can participate fully in our democratic society, and knowing Math and Science so they are prepared for future jobs. What will you do? Our kids deserve better.
- 5. Our Administration likes to say that they are transparent. The classic example of when they were not was in September of 2017 at a board meeting when I asked former administrator Josh Carpenter if the District had gotten the PARCC scores. He said they had. I asked him what they were, and he said that he did not look at them. I said, "You didn't even look to see if they went up or down?" He said that the had not. Everyone knew that he was not being truthful; the Superintendent did not respond either. What will you do to make sure that this Administration is transparent and open with you and the community? Our kids deserve better.
- 6. When residents and former 59 teachers come forward and bring up issues on finances, will you ignore that we are running a deficit and projected to run one for several years? What will you do? Our kids deserve better.
- 7. When you look around your neighborhood and see more and more kids going to private schools, rather than a 59 school, what will you do? Our kids and our communities deserve better than they have gotten from the Administration and previous board.

I wish you luck. You have your work cut out for you. We are here to work with you, but we will also not hesitate to point out things that our district should be doing to improve the education of all our kids. Our kids, our communities deserve what they have not received, the very best that we can offer.

have watched you all work very hard on this campaign and look forward to the good work you will do as leaders of the district and voice of the community. Over the last four months, I have been actively involved in the campaign in one form or another. I am especially proud that some of our PTOs came together to hold a candidate forum to provide an opportunity for our families to hear directly from their school board candidates. It was interesting to witness the campaign. I was told over and over it was the only thing left to do. In the meantime, the impact of the curriculum concerns became more evident in the form of continued low and declining student achievement results in math across all demographics, the results of a teacher survey and an increasing lack of academic readiness witnessed in junior high students. The administration is now acting with the curriculum committee but the work will take time and needs to be closely monitored. I say this because the administration does not necessarily agree with the evidence I just mentioned. They do not believe our student achievement data Mccs Sunty is indicative of any concerns, in part because of limitations or flaws in the assessments themselves. There may be valid concerns with these tests but it is up to this administration to determine effective means to measure the academic achievement of our students and provide evidence of such achievement to parents. A strong, research based curriculum would undoubtedly provide such means. Included in the platforms of all the school board candidates was to celebrate the successes of this district but also to address the curriculum deficiencies. I am confident that all of you will make this a top priority. I hope you will look beyond the limited scope of the previous board and hold the administration accountable for providing a robust curriculum designed to meet the needs of and set high standards for all students, and which will lead to measurable student academic growth to at least grade level and provide teachers with the necessary materials, training and an open line of communication. We need to again make measurable student academic achievement a priority. We need to balance new trends in education with needs of students and teaching practices which may be considered traditional but continue to be effective. Students are in school seven hours a day, five days a week, nine months year. There is time in the day to get it all done. Let's do this, together.
