3.0 **PRESENTATION**

3.01 Success For Life Award

The CCSD59 Board of Education announced the Success for Life Award. This award is a new way for the district to recognize and honor individuals making a significant contribution to the CCSD59 community through their time, actions, talents and dedication. The honorees selected exhibit compassion, service, and strive to be a role model for others as they seek to make the world a better place. The mission of CCSD59 is "Preparing Students to be Successful for Life", and the recipients of the CCSD59 Success for Life Award embody the spirit of our mission as they are not only individually successful in their own lives, but they have found success by making a difference in the lives of others.

The 2020-21 recipients of the CCSD59 Success for Life Award are Daniel Salgado-Alvarez, an alumnus of CCSD59, and Deputy Majority Leader Laura Murphy, for their role in inspiring the Cards 4 Kids Act which allows access to a free library card for low-income students living in unincorporated areas of IL not served by a municipal library.

Daniel presented the Cards 4 Kids Act concept to Deputy Majority Leader Murphy as a way to provide library services for students who were not previously eligible to receive a free library card. The Cards 4 Kids Act provides library access for about 1,200 CCSD59 students and another 400 Elk Grove High School students.

A plaque honoring their efforts was presented to each recipient.

Daniel thanked Deputy Majority Leader Murphy for helping him turn his idea into a reality so kids could have access to the library. He also thanked CCSD59 and the board for the award.

Deputy Majority Leader Murphy spoke about the history behind the cause and felt very humbled by the award.
