RESOLUTION: PREPARATION OF 2020 TAX LEVY AND SETTING THE DATE FOR THE PUBLIC HEARING

Background

Recommendation

adopt the following resolution:

Cook County taxing districts adhere to the Truth in Taxation Law (35 ILCS 200/18-55; Division 2). This law requires the District to estimate the necessary amount of its aggregate levy not fewer than 20 days before taking action to adopt the levy. If the estimated levy exceeds 105% of the amount extended on the aggregate levy of the preceding year, then the District must follow the specific public notification requirements.

Regardless of the levy amount, the District considers it a good practice to continue with the spirit of the Truth in Taxation Law by complying with notification and public hearing requirements. This resolution authorizes the Administration to proceed with the preparation of the 2020 levy and to announce the public hearing 2020 date of November 9, 2020.

RESOLUTION: APPROVAL OF AMENDMENT TO PHASE TWO AGREEMENT

BETWEEN CONTROL TECHNOLOGY & SOLUTIONS, L.L.C. AND COMMUNITY CONSOLIDATED SCHOOL DISTRICT NO. 59

Background

This Phase Two Amendment is based on the terms and conditions as described in the contract between CCSD59 and Control Technology & Solutions, L.L.C., dated February 10th, 2020.

Unit Ventilators are to be replaced at Grove Junior High, as well as Brentwood. Initially, Forest View and Devonshire were scheduled to have these done. However, Grove and Brentwood were not in the initial Phase Two plans. The Facilities Committee requested that these sites be researched, so that all facilities with univents have up-to-date mechanicals. Additionally, asphalt work is in the Phase Two Amendment. After further review, there is additional patchwork that is needed throughout the District. Lastly, sound blankets are an option to cover the Rooftop Units at Grove. This is due to the sound being emitted.

All work will be substantially complete by the end of Summer 2021. If accepted, this work and price will be added to the Amendment. The original amount of the Phase Two Amendment is \$19,834,005. The additional scope described in this change order increases the Amendment amount by \$1,300,000. The new total will be \$21,134,005. It is a 'not to exceed' amount.

CCSD 59 Phase Two Amendment to Scope of Work

Below are the modifications/additions to the scope of work and additional cost for the CCSD 59 Phase Two Project.

Proposal to be based upon:

- Civil Engineering Drawings prepared by Applied (a Division of RTM)
- ♦ Scope of Work as Described.

This Phase Two Amendment is based on the terms and conditions as described in the contract between CCSD 59 and CTS Group, dated February 10th, 2020.

CTS will furnish all labor and material for the scope of work described below.

CTS proposes to do this work on a fixed price basis.

All Work will be substantially complete by the end of Summer 2021.

If accepted, this work and price will be added to the Amendment Signed July 16th, 2020. The original amount of the July 16th Amendment is \$19,834,005. The additional scope described in this change order increases the Amendment amount by \$1,300,000. The new total will be \$21,134,005.

SCOPE DESCRIPTION:

Unit Ventilator Replacement:

- 1. Location is Grove Junior High School and Brentwood Elementary School:
 - a. All Existing Unit Ventilators
 - b. Work to be performed to Demolish and remove unit ventilators. Furnish and install new horizontal unit ventilators. Provide piping and hydronic specialties as required tying in unit vents to existing system. Provide sheet metal transitions and fittings as needed to connect to existing ductwork. Existing louvers/sleeves to be modified as needed. Modify Flooring as needed. Modify existing cabinetry as needed. Paint and Patch as needed. Furnish and install insulation on new piping installed match existing thickness and type. Provide startup and owner training of new equipment. Provide test and balance of the unit ventilators.
 - i. Building automation replacement is part of existing contract.

Asphalt Work:

1. Per the Civil Engineering Drawings prepared by Applied (RTM), CTS will perform all work noted as A, B, & C. Items labeled as D are already included in the amendment for Phase 2.



Sound Blankets:

- 1. Location is at Grove Junior High School:
 - a. CTS to install "Sound Blankets" on RTU 1, 5, & 8.
 - b. The sound blankets will reduce the noise transference but will not completely eliminate the noise produced by the units.

By Signing this proposal CCSD 59 and CTS Group agree to the scope of work and value stated in this proposal.
