### COMMUNITY CONSOLIDATED SCHOOL DISTRICT 59 Elk Grove Township Schools

RESOLUTION: APPROVAL OF WOLD EDUCATIONAL ALIGNMENT STUDY PROPOSAL FOR REMAINING 11 SCHOOLS

### Background

Wold has submitted a proposal per the Board's request to complete Educational Assessments of the remaining 11 schools. They have previously completed the assessments for the three junior high schools, as well as Brentwood. The process would begin in February, 2024 with an anticipated completion and board presentation of the findings in August, 2024. The proposed fee structure is \$7,000 per school, which includes a full assessment of each of our buildings from a teaching and learning perspective.

Their services will start with their architects and planners walking the schools, assessing floor plans, and aggregating existing space data. They will interview administrators, principals, and staff in order to verify uses of learning spaces, identify special program uses, and document needs for any future initiatives. The Educational Alignment Assessment will evaluate how adequate a school building and site are equipped to deliver future-ready instructional curriculum.
