

ANNOUNCEMENT OF MEMBER VACANCY

The Board of Education of School District 59 intends to make an appointment to fill the vacancy that occurred when a seated board member resigned on January 9, 2024. Please note that this appointment is for time remaining until the next board election in 2025. The new board member would need to run for election in the April 2025 school board election to retain a seat on the Board of Education.

Who can apply? Residents of School District 59 who are 18 years of age or older, have lived in the district for at least one year immediately preceding the date of appointment, and are registered to vote in School District 59 (and are not a child sex offender.)

Board action? It is anticipated that the Board will take action to appoint a candidate at a Board meeting on or before March 9, 2024.
